

# REQUEST FOR PROPOSAL

## CONSTRUCTION OF THE GRAND CHEMIN FISHING FACILITY

The NATIONAL INFRASTRUCTURE DEVELOPMENT COMPANY LIMITED (NIDCO) in partnership with the Ministry of Works and Transport wishes to invite suitably qualified and experienced contractors for the Construction of the Grand Chemin Fishing Facility.

### SITE LOCATION

The site for the proposed works is located south of La Lune Road, Grand Chemin, Moruga.

### SCOPE OF WORKS

The Scope of Works included in this Contract involves the construction of a single storey structure with a floor area of approximately 2200 m<sup>2</sup> supported on driven piles to accommodate locker rooms, repair facilities, wholesale and retail areas, water storage and ice makers; as well as supporting services and site works such as a package waste water treatment plant, rock revetment, slip way, and other infrastructural works.

### ELIGIBILITY

Submission of proposals is open to all Respondents who can demonstrate they have the financial resources, experience and technical expertise to provide the required services. Joint ventures and parent companies will be jointly and severally liable under the contract and will have to provide guarantees. Evaluation of proposals will be based on technical requirements including: **(1) Background Information & Organization of the Entity and Record of Performance (2) Financial Capacity of the Respondent (3) Available Manpower and Capability (including Qualifications and Experience of Proposed Key Personnel) (4) Available Plant, Equipment and Material (5) General Experience and Similar Work Experience (6) Management and Implementation Strategy.**

### PURCHASE OF RFP

The RFP may be viewed and/or purchased between the hours of **9.00 am and 3.30 pm, Monday to Friday from Thursday 28<sup>th</sup> November 2019**. The package can be purchased for a non-refundable fee of **TT\$7,000.00 or US\$1,030.00**, payable **ONLY** by certified cheque (local respondents) or wire transfer (international respondents).
