

INVITATION TO TENDER

LANDSLIP REPAIR PROGRAMME (LRP) PHASE 2A

The NATIONAL INFRASTRUCTURE DEVELOPMENT COMPANY LIMITED (NIDCO) in partnership with the Ministry of Works and Transport (MOWT), wishes to invite suitably qualified and experienced Contractors to Tender for Three (3) Tender Packages comprising of Four (4) landslip sites under the Landslip Repair Programme (LRP).

SCOPE OF WORKS

The following is a brief Scope of Works for each Tender Package. **Additional details of the works will be contained in the Terms of Reference (TOR) section of the Invitation to Tender (ITT):**

ITT 2112/01-CP#07-L#15/L16 – Sisters Road (5.5-5.51km)

- Excavate the northern and southern slopes of road to a maximum depth of 6m and replace it with compacted layers of 150mm with imported selected structural backfill material.
- Installation of drainage, earth works and flexible road pavement for 160m within the established ROW.

ITT 2112/02-CP#04-L#26 - San Francique Road LP #143 House #390

- Landslip repair using 600mm Dia. CFA Piles with encased H-beams and an RC capping beam within the ROW (i.e. Contiguous Pile Wall – Total length = 65m)
- Demolition of the existing failed wall along the western edge of San Francique Road
- Backfilling of the contiguous pile wall using structural backfill, installation of a sand capping layer for construction of a flexible road pavement within the ROW

ITT 2112/03-CP#02-L#29 - Naparima Mayaro Road LP#353

- Installation of 75m long Pile-Supported Reinforced Concrete Cantilever Retaining Wall on the northern side of the road.
- Installation of a new permanent Reinforced Concrete PVC Duct Bank parallel to the retaining walls.
- Construction of a flexible road pavement within the established ROW which varies between 11.4m –12.5m.

ELIGIBILITY

This ITT is open to all respondents who can demonstrate they have the experience, technical and financial expertise to provide the required services. Evaluation of proposals will be based on requirements including: Organizational Background Financial Capability, Available Manpower, Plant & Equipment, Work Experience and Management and Implementation Strategy.
