

REQUEST FOR QUOTATION

PROVISION OF DIVER SERVICES FOR ROUTINE CLEANING & MAINTENANCE OF UNDERWATER AREA TO NIDCO'S FLEET OF 41M WATER TAXIS

The National Infrastructure Development Company (NIDCO) is seeking to engage qualified dive contractors for the provision of diving services to conduct routine cleaning & maintenance of the underwater area to NIDCO's fleet of 41m Water Taxis to be called off on a drawdown basis.

SCOPE OF WORKS

Supply of Dive Team to conduct the following:

1. Cleaning all marine growth including barnacles from Hulls (Port and Starboard).
2. Inspect all hulls, transom and jet anodes and replace when necessary as well as report on current deterioration/condition (Port and Starboard).
3. Clean and inspect Port and Starboard hulls and report on condition of anti-fouling.
4. Check Port and Starboard jet shafts each dive and remove debris as encountered.
5. Check and clean Port and Starboard transom interceptors, jet drives (inclusive of nozzles, cones, rams & buckets), jet ducts, inlets, valves and grills and report on issues as necessary.
6. Check all salt water intakes and clean each dive to maintain desired flow.
7. Pay special attention to coating damage/bare metal and report same to owner immediately.
8. Notify owner of items that seems out of sort and or any maintenance or repair requirements observed.
9. Take pictures of general condition and deficiencies and present to owner.
10. Dive report inclusive of photographs to be submitted within three (3) days after each dive.
11. Contractors MUST be able to work on short notice.
12. Contractors MUST supply call out rates.
13. Contractor MUST be able to perform In-Water Surveys as per DNV Specifications.
14. Contractors MUST provide all certifications for their divers.

SUBMISSION OF DOCUMENTS

The One (1) Envelope System will be utilized. Please note that the dimensions of the Tender Box slot are **4" High and 18" Wide**. Respondents are advised that the name of the company submitting the Quotation should be clearly marked on the envelopes. **Quotations MUST NOT be emailed to NIDCO. Emailed submissions will result in disqualification.**

ELIGIBILITY

This RFQ is open all respondents who can demonstrate they have the requisite technical experience to provide the required services.

MANDATORY DOCUMENTS

Quotations must be accompanied by the following, which must be valid at the time of closing.

- Value Added Tax (VAT) Certificate
- NIB Compliance Certificate
- Tax Clearance Certificates issued by the Board of Inland Revenue.

Evaluation of proposals will be based on requirements including: **Diver's Certifications, Methodology Statement, Insurance (Public Liability, Workmen's Compensation) and Financial Proposal.**

NIDCO does not bind itself to accept the lowest or any tender. NIDCO reserves the right to award a single contract for the full quantities stated in the Technical Specifications or to award separate contracts for lesser quantities, as the Company sees fit.
