REQUEST FOR QUOTATION

PROVISION OF PEDDLER SERVICES FOR THE TRANSPORTATION & PUMPING OF DIESEL FUEL TO NIDCO'S FLEET OF VESSELS (41M WATER TAXIS & PORT FERRIES)

NIDCO is seeking to engage the services of suitable Peddler Contractors approved by the Ministry of Energy and Energy Industries (MEEI), for the provision of Transportation and Pumping of Diesel Fuel to NIDCO's fleet of 41m Water Taxis and Port Ferries.

SCOPE OF WORKS

The successful Contractor will be required to provide peddler services for the transportation and pumping of diesel fuel as follows:

41M WATER TAXIS (3 No.)

- Supply of diesel fuel Monday to Saturday 12:00pm to 9:00pm or as otherwise requested on an emergency/call out basis to NIDCO's 41m vessels as berthed at the Lady Hailes Avenue Terminal in San Fernando or at the Port of Spain Terminal. The preferred bidder must also demonstrate the ability to deliver fuel on Sundays and public holidays upon short notice in the event of charters and other special sailings.
- Verify that fuel is not contaminated with water by using water finding paste.
- Submit weekly fuel samples in accord with requirements.
- Provide and maintain certified road tank wagons (RTW) which meet key performance indicators as outlined by NIDCO.
- Deliver fuel according to the stipulated schedule.
- Meet all statutory Health, Safety and Environmental guidelines as these pertain to the transportation and pumping of diesel.
- MUST** be Ministry approved peddler contractors.

PORT FERRIES (3 No.)

- Supply of diesel fuel Monday to Sunday 10:00am to 6:00pm or as otherwise requested on an emergency/call out basis to the Port Ferries berthed at the GSS Jetty Port of Spain Ferry Terminal or otherwise advised. The preferred bidder must also demonstrate the ability to deliver fuel on Sundays and public holidays upon short notice in the event of charters and other special sailings.
- Verify that fuel is not contaminated with water by using water finding paste.
- Submit weekly fuel samples in accord with requirements.
- Provide and maintain road tank wagons (RTW) which meet key performance indicators as outlined by NIDCO.
- Deliver fuel according to the stipulated schedule.
- Meet all Health, Safety and Environmental guidelines as these pertain to the transportation and pumping of diesel.
- MUST** be Ministry approved peddler contractors.

Respondents are advised that the name of the company submitting the Quotation should be clearly marked on the envelopes. **Proposals MUST NOT be emailed to NIDCO. Emailed submissions will result in disqualification.**

This RFQ is open to Ministry-Approved peddler contractors **only** who can demonstrate they have the experience, and technical expertise to provide the required services.
