## **VALENCIA TO TOCO ROADWAY SEGMENT 8 RAMPANALGAS**

The NATIONAL INFRASTRUCTURE DEVELOPMENT COMPANY LIMITED (NIDCO) in partnership with the Ministry of Works and Transport (MOWT), invites suitably qualified and experienced Contractors to bid for the **Valencia to Toco Roadway Segment 8 Rampanalgas** tender package.

#### **SCOPE OF WORKS**

Key elements of the works include, but are not limited to the following:-

- Upgrade and widening of approximately 2.3km of the existing roadway to international standards.
- Upgrade of approximately 250m of Jerome Trace.
- Construction of approximately 500m of new connector roads.

Additional details of the works will be contained in the Terms of Reference (TOR) Section of the Invitation to Tender (ITT).

#### **ELIGIBILITY**

This Invitation to Tender (ITT) is open to all respondents who can demonstrate they have the experience, technical and financial expertise to provide the required services. Evaluation of proposals will be based on requirements including: Background Information and Organisation of the Entity, Financial Capacity, Manpower and Experience of Proposed Key Personnel, Plant, Equipment and Material available for the project, General Experience and Similar Work Experience and Management and Implementation Strategy.

Following the proclamation of the Public Procurement and Disposal of Public Property Act (2015), Contractors who are desirous of providing goods, works or services to NIDCO, are advised that they must first, be registered with the Office of the Procurement Regulation (OPR) in this specific category. Any party seeking to participate in procurement proceedings must input information and upload relevant associated documentation into the Procurement Depository, in accordance with Section 29(1) of the Act. Section 26(3) of the Act, places full responsibility on the contractor to ensure the accuracy of the information provided
