IMPLEMENTATION AND OPERATION OF AN ON-STREET PARKING SYSTEM IN THE CITIES OF PORT-OF-SPAIN AND SAN FERNANDO

The Government of Trinidad and Tobago (GORTT), through the Ministry of Rural Development and Local Government is desirous of implementing an on-street parking system in the cities of Port-of-Spain and San Fernando. The services of an appropriately experienced and knowledgeable legal consultant is required to develop, and provide advice to NIDCO on, the Design, Build, Finance, Operate and Maintain (DBFOM) contract required for this project.

DESCRIPTION OF WORK

The Scope of Works to be provided by the legal consultant includes:

- Drafting of the Contract Agreement, Conditions of Contract and finalization of all RFP documents for the Installation and Operation of Parking Meters in the cities of Port-of-Spain and San Fernando using a Design, Build, Finance, Operate and Maintain (DBFOM) model; and
- Providing legal advice and or representation to NIDCO through the project phases.

ELIGIBILITY

Submission of tenders is open to all Respondents who can demonstrate that they have the requisite technical experience along with a proven track record of providing similar services as outlined in the Request for Proposal. Evaluation of tenders will be based on requirements including; but not limited to: Technical Capability, Qualifications and Experience of Proposed Key Personnel, Similar and Relevant Projects undertaken by the Respondent's proposed key personnel.
