

REQUEST FOR PROPOSALS RFP 2508/01

The NATIONAL INFRASTRUCTURE DEVELOPMENT COMPANY LIMITED (NIDCO) wishes to invite suitably qualified and experienced Insurance Brokers for the Provision of NIDCO's General and Motor Vehicle Insurance Portfolio.

SCOPE OF WORKS

Key elements of work include, but are not limited to, the following:

Provision of Brokerage Services and Coverage in respect of NIDCO's General Insurance and Motor Vehicle Portfolio including, but not limited to, the following:

- Providing expert advice to NIDCO in all areas of insurance including, but not limited to, training sessions.
- Providing advice on the Strategic Management of the insurance requirements of NIDCO including, but not limited to, the periodic review of all policies
 to ensure adequate coverage in keeping with the value for money metrics.
- Providing expert representation of NIDCO in all negotiations with insurers, underwriters and their agents.

ELIGIBILITY

This Request for Proposals is open to all respondents who can demonstrate they have the experience, technical and financial expertise to provide the required services.

Evaluation of proposals will be based on requirements including Organizational Background and Qualifications, Financial Capacity, Brokerage Services Methodology and Price.

Following the proclamation of the Public Procurement and Disposal of Public Property Act (2015), Contractors/Suppliers who are desirous of providing goods, works or services to NIDCO, are advised that they must first, be registered with the Office of the Procurement Regulation (OPR) in this specific category. Any party seeking to participate in procurement proceedings must input information and upload relevant associated documentation into the Procurement Depository, in accordance with Section 29(1) of the Act. Section 26(3) of the Act, places full responsibility on the contractor/supplier to ensure the accuracy of the information provided.
